Interference: Use of Capitol Square shall only be done in a manner so as no to interfere or compete with the normal business proceedings of the state.  Food/Beverage: No food or beverages, or merchandise shall be sold or dispensed on Capitol Square Grounds without the express written consent of C.S.R.A.B. No transient vendors are permitted to use the Capitol Square facilities. Food and beverage dispensing shall be in accordance with all state and federal laws.  Liability: The user organization shall indemnify and hold harmless the state of Ohio and C.S.R.A.B. against any and all claims, demands, actions, or causes, of actions, together with any and all losses, costs, or related expenses asserted by any person or persons for bodily injury, death, or property damages resulting from or arising out of this permitted use of Capitol Square.  Smoking: Smoking is prohibited in Capitol Square buildings.
